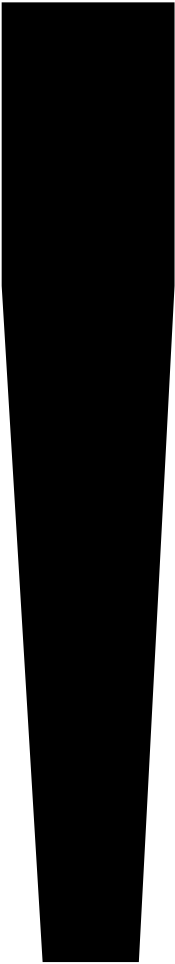

The Arizona law laid out four (disturbingly vague) criteria on which to judge the illegality of a curriculum. The court found three of them to be valid, but one to be too general. Both sides are appealing the court decision.
