- A. Check Special Tabulations page for "unanswered questions".
- B. Most of the 2000 census briefs have been released.
- C. The "WE" series is in the works, similar to the 1990 series.
- D. Census 2000 Summary File 2 DVD is in the mail.
- E. Summary File 4 is in production at manufacturer. There will be 4 DVDs.
- F. Census 200 American Indian Area/Alaska Native Area/Hawaiian Home Land PDF Map Files are in the mail.
- G. Census 2000 Migration Data CD-ROM is in the works. Will contain 121 ASCII files showing migration data for various levels of geography. About 10 of these files are on the website (site also has some reports that aren't on the CD). These are large files - Access is recommended to view.
- H. Census 2000 Special Equal Employment Opportunity (EEO) tabulations are on the web and a CD-ROM is in the works. There are 48 unique data sets (24 for continental U.S. and 24 for Hawaii). 26 of the 48 data sets will be on the website. These plus an additional 10 will be on the CD-ROM of the EEO file.
- I. The Public Use Micro-data Sample (PUMS) files will soon be mailed. At 1 & 5 percent level. DVD uses the Ivation Beyond 20/20 software (Census has covered cost for depositories). For user help see NHS website. Discs will inc. PDF maps for PUMAs and Super-PUMAs.
- J. Characteristics of American Indians and Alaska Natives is on the web, but has not yet distributed in print.
- K. See Census 2000 Notes and Errata Report on the web for updates to all CD/DVD products.
- L. Mapping products: Congressional District Maps are available in print and will be in PDF form on disc. There are no plans for an updated District Atlas (CQ might do something). Maps and tables by CD will be on DVD in 2004. No current plans for Metropolitan Area maps.
- M. 2002 Economic Census: first reports due out in First Quarter 2004.
- N. Historical Census volumes: large PDFs will be up in 3-6 months as static pages. Near complete though there are some missing volumes (should be found later); generally good quality. Will inc. decennial Census, Statistical Abstracts,
